

Problematics





Based on NMAA data, for the period from February 24, 2022 to April 3, 2024 at least 959 (around 10% are children) civilians have been affected by ERW, 295 of them have died.

The largest number of cases occurred in such regions: Kharkivska, Khersonska, Mykolaivska and Donetska oblasts.

The actual figures are considerably higher due to underreporting and limited access to the areas of active hostilities.

It is obvious that with this indicator Ukraine is the **most contaminated country in the world**.

To unite and increase the potential of the best experts in Ukraine in the field of mine action (MA).



To establish Uniform National Standards for MA in Ukraine and to ensure control over compliance with them.



Consolidate the efforts of civil society, the state, the media and international partners to create appropriate working conditions, technical support and protection of Ukrainian deminers.

Mine Action Operator





From 11 October 2022, UDA success fully passed the certification process in MAC (Chernihiv) MoD and became a certified mine action operator in Ukraine.

From 16 June 2023, UDA obtained a NTS certificate.

UDA is planning to receive all available certificates soon.

34 signed Memorandums, Partnership, Teaming and Grant Agreements with Donors, State Bodies, Local Authorities, International and National NGOs.



Non-Technical Survey



Directly after receiving NTS certificate in MAC (Chernihiv) MoD UDA started non-technical survey operations. Currently, UDA deployed 4 NTS Teams. UDA AoR for today is: Chernihivska oblast (Pryluckiy raion) Mykolaivska oblast (Bashtanskiy raion and Mykolaiv city).

Prepared more than 183 NTS reports. The total surveyed area more than 3 800 mln. m2.



Implementing partner - Mine Action Operator

Certified Ukrainian mine action operator Demining Solutions (DS) since 2019 is implementing partner of UDA (Number 1 in the list of MoD).

On June 26, 2023, DS successfully passed the next stage of the certification process at the Demining Center (Kamyanets-Podilsky) and received 5 certificates of conformity for three years of humanitarian demining (26 June 2028).

In addition, in December 2023 DS obtained the EOD certificate along with all necessary permissions which enables to purchase, transporting, handling the explosives and conduct the demolitions.







Current humanitarian demining




After the full-scale invasion of the Russian Federation into Ukraine within the framework of the project from the Ukraine Humanitarian Fund OCHA, the UDA, together with the implementing partner DS, was the first to start the humanitarian demining procedure in new circumstances for our state. On May 3, we started NTS in the Kyiv and Chernihiv regions. From the beginning of June, we began battle area clearance in the liberated territory of Makariv hromada of the Bucha rayon.

Currently, DS conducts humanitarian demining (including NTS) in almost all affected regions of Ukraine and has already released 3 agricultural fields (with a total area of more than 100 hectares) to the Makariv hromada.

In order to improve the training of sappers, continuous training and additional training is carried out, in particular, at the EOD Schools of MAT Kosovo (EOD Level 2, EOD Level 3+) and TetraTech (EOD IMAS 1).



Operations





During the 2023 year, NTO/EORE teams worked in Mykolaiv, Dnipropetrovsk, Kharkiv, Sumy, Kherson, Chernihiv and Kyiv oblast.

In total, more than 1,250 million square meters were surveyed (CHA/SHA), on which 822 NTS reports were completed and submitted to National Mine Action Center.



Operations





Land release

Since April, one clearance team (10 people) has resumed work in the Makariv hromada of the Bucha raion.

On September 15, 2023, a cleared site of agricultural land with an area of 301,495 square meters was transferred to the owner (Makariv hromada of Kyiv oblast) after the successful quality control.

In total, 1,064 million square meters of land were recognized as "no evidence of contamination" according to the results of the NTS.



Mechanical Demining





UDA takes active measures to start the process of mechanical demining in Ukraine, primarily based on the best world practice.

Plan for 2024 start the Capacity Building Project for mechanical demining with using of EOD Robotic System.
